The following, which took in several later items on the agenda, were discussed:-

Boundaries

Footpath from Bensted Close to the Hall

Agreement from David Hubble to the establishment of a footpath inside the hedge on his land has been received. Contact has been made with the Estate Manager of the Tregothnan Kent Estate and it is hoped that this matter will proceed to a satisfactory conclusion in the near future.

Health & Safety

The current Play Area Inspection Report raised no areas of concern at the present time. KE will contact Yorkes to obtain a quotation for the repairs to the supporting posts of the safety netting along the Bowls Club boundary.

Finance

Discussion took place on the amount of the donation which it was felt would be required from the Parish Council for the next year. It was agreed that we should request the Parish Council to consider a donation of £5,800 for 2010.

Administration

It was agreed that the invoice for £80 in respect of the repairs to the Notice Board should be sent to the Parish Clerk for payment from the KGF budget.

Other Matters

With regard to the query regarding the boundary line to the Playing Field, the Parish Council had agreed to wait for a formal request from Mr Savage regarding the transfer of ownership.

As the Parish Council are the registered keyholders in respect of the Playing Field gate, MC was asked to request the Parish Clerk to write to Poyntell Ltd authorising the purchase of an additional key for the Playing Field gate by the Management Committee.
