4. Health & Safety

The Secretary was instructed to contact Alan Bishop to see whether it was possible to install another light.
- The Committee also wished to thank both the Parish Clerk and the Parish Plan Committee for their support in obtaining the necessary grant and dealing with the financial needs of the installation of the Play Equipment. We do really appreciate the encouragement and support we have received. The Play equipment looks really good and when the mud clears and the grassed area has recovered it is hoped that this will provide many hours of entertainment for the children. Discussion took place as to the maintenance of the area - grass cutting, strimming, etc. and the Secretary was asked to instruct Robert Cox to include this in the routine tidying of the car park area and entrance to the car park.
