# 3. MINUTES OF PLANNING MEETING HELD ON 9<sup>TH</sup> DECEMBER 2010

The Minutes of the meeting had been previously distributed and were **Agreed** to be an accurate record. The Chairman signed off the official copy.

## 4. PLANNING APPLICATIONS

The following applications were considered and recommendations made:

## 4.1 Land at South End of Water Lane - MA/10/1216

Change of use of land to the keeping of horses and erection of a building comprising two stables, a tack room, and hay and tractor store, an access and hard surfacing. Council recommendation: Approve

## **4.2 Bridge House, East Street** – MA/11/0141

Listed building consent to remove external door and partition wall to shower room. Council recommendation: Approve.

#### **4.3 The Grove, Grove Lane** – MA/11/0129

Listed building consent for the removal of existing in-fill panels (hard cement rendered) and replacement with new panels consisting of a traditional lime finish externally, with a modern build up internally incorporating insulation. Council recommendation: Approve.

## 5. REPORTED DECISIONS

The following decisions received from MBC were **Noted**:

### **5.1** Gudgeon Oast, West Street – MA/10/1021

Conversion and adaptation of the oast to form a two bedroom residential dwelling. Council recommendation: Approve. MBC: Granted Planning Permission.

## **5.2 1 Shepherds Cottages, Water Lane** – MA/10/1034

Erection of a single storey extension, a two storey rear extension, re-roofing of existing building, replacement of metal windows with wooden windows, recladding with brick to flank elevation and erection of a detached shed. Council recommendation: Approve. MBC: Granted Planning Permission.

#### 5.3 1 Shepherds Cottages, Water Lane – MA/10/1237

Listed building consent for the erection of a single storey side extension, a two storey rear extension, re-roofing of existing building, replacement of metal windows with wooden windows, recladding with brick to flank elevation, alteration of fireplace, other internal alterations and demolition of shed. Council recommendation: Approve. MBC: Granted Planning Permission.

## **5.4 Shepherds Cottages, Water Lane** – MA/10/1430

Retrospective application for change of use of land to form access and hard surfacing for storage of agricultural machinery. Council recommendation: Refuse. MBC: Granted Planning Permission.
