4. PLANNING APPLICATIONS

The following applications were considered and recommendations made:

4.1 Freelands, West Street – MA/12/1211

Roof extension and erection of a front porch (resubmission of MA/12/0779). Parish Council recommendation: Do not wish to comment/object.

- 2, Hammonds Cottage Cheveney Farm, Vicarage Lane, Yalding MA/12/1206 Application for Listed Building Consent for the erection of a two storey side extension, insertion of dormer window to front, single storey rear extension and other alterations. Parish Council recommendation: Do not wish to comment/object providing the proposed work meets Listed Building Regulations.
- **4.3 2, Hammonds Cottage Cheveney Farm, Vicarage Lane, Yalding** MA/12/1230 Erection of a two storey side extension, insertion of dormer window to front, single storey rear extension and other alterations. Parish Council recommendation: Do not wish to comment/object.

5. **REPORTED DECISIONS**

The following decision received from Maidstone Borough Council were **Noted**:

5.1 Scuffits, Water Lane – MA/12/0447

Erection of single storey garden room extension and raised flagstone area. Parish Council recommendation: Approve the application and request the application is reported to Planning Committee. Maidstone Borough Council decision: Refused planning permission.

5.2 1, Shepherds Cottages, Water Lane

Retrospective application for erection of close boarded fencing and entrance gates and for the laying of hardstanding.

Parish Council recommendation: More detailed plans were requested to clarify the application, but Maidstone Borough Council did not want to ask the applicant for further plans due to the application being retrospective. Due to the vagueness of the supplied information the Parish Council was unable to provide any comments.
