5. PLANNING APPLICATION

The following application was considered, and recommendation made:

5.1 Hilltop Farm, Shingle Barn Lane West Farleigh - 20/501477/FULL

Conversion of an agricultural building to a single residential dwelling (previously approved under reference 19/505751/PNQCLA), including erection of a single storey rear extension. Parish Council recommendation: The Parish Council had previously questioned whether this development should be allowed on sustainability grounds, but prior approval was granted by MBC under permitted development rights. Members could see no reason to recommend refusal of the planning application for the dwelling, given the modest size of the building and as permission has been given to convert the building. No objection.
